WHEREAS, the City of Albany is in the process of constructing the West Hill Community Center, which will be a walkable meeting space with programming for seniors, childcare services, fitness and lounge spaces, multipurpose classrooms, and will provide access to many other resources and opportunities to the community; and

WHEREAS, the architectural plans for the Community Center allow for the installation of public art on the façade of the building; and

WHEREAS, the community has requested that a mural be installed on the façade, honoring individuals who have made significant contributions to the West Hill neighborhood and the City of Albany; and

WHEREAS, Sgt. Henry Johnson, Brother Yusuf Burgess, Dr. Alice Green, Edmund O’Neal, and Sarah Curry-Cobb have been identified as four individuals who, through their dedication to, and efforts on behalf of, their community, City, and nation, are richly deserving of commemoration on the West Hill Community Center mural;

TITLE
