**Questions and Discussion:**

- Majority Leader Farrell, chair of the committee, called the meeting to order.
- Ordinance 21.71.24 was held for later discussion.
- Ordinance 24.81.24
  - *Council Member Clarke moved to pass Ordinance 24.81.24 out of committee with a positive recommendation pending amendments to clarifying exceptions for operation of human propelled devices on the sidewalk; establishing that the Chief of Police shall consult with the Division of Traffic Engineering and Commissioner of Recreation on specially designated occasions for vehicle use in city parks; striking consultation with the Active Transportation Planning Commission; and adjusting the bill drafting; seconded by Council Member Anane, and passed by voice vote.*
- Local Law L of 2024
  - The Committee on Law, Buildings and Code Enforcement discussed City of Albany staffing concerns with the Mayor's Office as well as the departments of Administrative Services, Police, Engineering, and Water.
  - *Council Member Keegan moved to pass Local Law L of 2024 out of committee with a positive recommendation pending amendments, seconded by Council Member Conti, and passed by voice vote.*
