- Principal Planner Avi Epstein presented on Ordinance 61.111.25.
 - Committee Member Deborah Zamer inquired if the vacant lot was once housing, to which Principal Planner Epstein shared that they were houses that were lost in a fire about five to six years ago.
 - Committee Member Zamer asked if the trust will purchase the lot, to which Principal Planner Epstein noted that they already own it.
 - Committee Member Thomas Hoey inquired if the lot would be tax exempt because a religious entity bought the lot, to which Principal Planner Epstein responded that he was unsure and would look into it. He shared his belief that the lot would not be tax exempt because it is separate from the mosque.
 - *Committee Member Sergio Adams motioned to move Ordinance 61.111.25 out of committee with a positive recommendation, which was seconded by Committee Member Zamer and passed by voice vote.*

- Director of Planning and Development Brad Glass presented on Ordinance 16.82.25.
 - Committee Chair Alfredo Balarin asked if this ordinance would make it easier to sell properties, to which Director Glass responded affirmatively.
 - *Committee Member Zamer motioned to move Ordinance 16.82.25 out of committee with a positive recommendation, which was seconded by Committee Member Hoey and passed by voice vote.*
