Introduction

This is the annual report to the Albany Common Council on the activities of the City of Albany Minority and Women's Business Enterprise Program, covering the period of the 2024 calendar year.

The Chief Compliance Officer is responsible for implementing the MWBE Program and Minority and Women Labor Utilization Plan Ordinance. [Adopted 6-18-1984; amended in its entirety 4-1-2002 by Ord. No. 13-22-02]. The intent of the Ordinance is to provide minorities and women the maximum opportunity to participate in City of Albany construction projects.

A note regarding Purchasing law: The City is required, under New York State law, to award construction contracts to the low bidder. The Compliance Office then works with the awardee in an effort to increase participation and meet the applicable MWBE and M/W Labor goals.

The projects monitored over the course of 2024 are not uniform in terms of the participation goal percentages that are indicated within their contracts.

- Prior to January 1, 2021, the program goals had been the same for many years, since at least 2011: 7.5% MWBE Subcontractor Participation and 17.8% Minority and Women Labor Utilization. Projects which went out to bid prior to 1/1/21 carry these goals. Because of the long timeframe inherent in many MWBE-applicable projects, seven of the contracts summarized in this report still reflect these goals.
- As of January 1, 2021, at the recommendation of this office, a policy change was put into effect which increased the MWBE Subcontractor Participation Goal to 15%. Additionally, a corresponding amendment to Ordinance 24.101.20 took effect, increasing the Minority and Women Labor Utilization Goal to 25%. Projects which went out to bid between 1/1/21 – 4/30/22 carry these goals.
- An additional amendment increasing the Minority and Women Labor Utilization Goal to 30% was subsequently passed and took effect May 1, 2022. Projects which went out to bid 5/1/22 and beyond carry a 15% MWBE Subcontractor Participation Goal and a 30% Minority and Women Labor Utilization Goal.

The MWBE Program and Minority- and Women-Owned Labor Utilization Plan Ordinance establishes that the Office is also responsible for implementing the City's MWBE Certification Program. The Ordinance specifies the following administrative duties:

- Identify minority- and women-owned businesses capable of successfully engaging in a competitive bid process for the procurement of construction and construction-related projects;
- Maintain a central directory of minority and women-owned firms;
- Discontinue and disqualify MWBE contractors and subcontractors when violations of policy and performance agreements occur.

Commentary

Notes on the Compliance Summary Spreadsheet (Appendix A)

In 2024, 125 contracts were monitored for MWBE compliance, a greater than 15% increase in the number of contracts monitored in comparison with the previous year. The total value of all monitored contracts for 2024 is \$135,680,628.62.

The contract data is organized in this way:

- A list of the contracts *completed in 2024*, organized by the managing City Department, with the ACDA projects listed separately from the rest of the completed contracts.
- A list of the contracts *in-progress in 2024* but not yet completed. These are also grouped by City Department, with the remaining few contracts that have the prior-to-2021 goals listed separately.

The spreadsheet also includes a column which specifies which MWBE Subcontractor goal and which M/W Labor goal is applicable to each contract; again, the contract goals reflect what year the contract was established.

The non-ACDA completed projects table includes a column which states the MWBE Eligible contract amount. This is because, in a few cases, either the City or a State agency has determined that some portion of the contract value is ineligible for MWBE goals due to the fact that that portion is for the provision of specialty materials or processes with the required vendor specified by name within the contract requirements.

Contracts Completed in 2024 - The data in this section shows the final compliance numbers, covering the entire life of each finished project. Some projects span multiple years by the time they are completed. 102 contracts were completed in 2024, with 76 of those being ACDA projects.

Of the 102 contracts completed in 2024, 80 met or exceeded their MWBE Subcontractor goal, and 82 met or exceeded their Minority & Women Labor goal.

MWBE Subcontractor Participation

At 20.68% the City has exceeded its MWBE participation goal of 15% for contracts completed in 2024.

A total of \$7,564,726.54 was paid to MWBEs on 2024's completed contracts, an increase of over 52% of the amount paid to MWBEs on the previous year's completed contracts.

Prior MWBE Subcontractor Goal – Three contracts which had the prior participation goal of 7.5% were completed in 2024. There are only four contracts with this goal attached that remain to be completed; and they are all expected to be completed by the close of 2025. All of the other contracts completed in 2024 had the 15% goal attached.

The overall MWBE participation rate for non-ACDA completed contracts was 19.34%

Of the 15 non-ACDA contracts which show MWBE participation below 15%, two of these were issued a partial waiver by the State agency providing funding: EFC (the Environmental Facilities Corp.) And in two cases EFC issued a full waiver of the MWBE requirement.

In the remaining instances, the Compliance Office granted partial waivers of the MWBE goal percentage in response to submitted waiver request documents. In two cases, the Compliance Office issued a full waiver.

Reasons provided by Prime Contractors for inability to reach the goal percentage include:

- MWBE firm would be chosen for the subcontract, however they don't meet the City's Apprenticeship requirement. Per the existing ordinance language, the Apprenticeship requirement cannot be waived.
- City-issued changes to the original contract scope and work areas which affect the planned utilization of an MWBE subcontractor.
- Limited availability of MWBEs due to the large number of municipal contracts in our area that have MWBE goals and are competing for the same pool of MWBE firms.
- MWBE quote significantly higher, and can't be negotiated lower.
- Limited scope of the work involved in the contract; limited opportunity within the scope of the contract to subcontract.
- Limited MWBEs that are capable of performing the type of work or the scale of the work involved in the contract.

The Compliance Office works closely with Prime Contractors to ensure that all avenues to meet the MWBE goal percentage are pursued. This process involves:

1. Obtaining from the Prime Contractor a Schedule of Values for the contract
2. Conducting searches of the qualifying MWBE directories and databases for the work types found within the Schedule of Values and providing the search results to the Prime Contractor.
3. Requiring that the Prime Contractor demonstrate that they have solicited quotes from the MWBE firms that were found through the database searches.
4. Making sure that City of Albany MWBEs are aware of the subcontracting opportunities on awarded contracts and encouraging them to connect with the Prime Contractor to offer a quote.
5. Requiring that Prime Contractors complete a Letter of Intent form with each MWBE subcontractor confirming the anticipated value of the subcontracted work or materials to be purchased.

The following actions are taken by the Compliance Office to enforce the MWBE ordinance in cases of low compliance levels:

- Contractors are required to submit waiver documents which may include a waiver request form, a waiver request letter providing a detailed explanation for the shortfall including steps taken by the contractor to try to correct the shortfall, a log of solicitations for quotes requested from MWBE firms, subcontractor correspondence and quotes.

- Phone calls and In-person meetings held with the contractor to review the goals, expectations, and procedures of the MWBE Program.
- Consultation with Corporation Counsel; letter sent to contractor by Corporation Counsel where appropriate.

M/W Labor Hours

Minority and Women Labor hours are at 26.42% of the total workforce hours for contracts completed in 2024. The City M/W Labor goal is 30%.

A total of 29,197.25 labor hours were worked by women and minorities on contracts completed in 2024; this is over 56% more MW labor hours recorded than on the previous year's completed contracts.

Contracts in-progress but not completed in 2024 – The data in this section reflects work hours and payments to MWBEs only through the year 2024, and therefore provides a snapshot of these contracts, but not a complete picture of compliance levels. Final totals for many of these projects will be available for the next annual report. Twenty-three projects were underway but not yet completed at the close of 2024.

MWBE Subcontractor Participation

By the close of 2024, a total of \$12,906,415.39 has been paid to MWBEs on contracts that are still in-progress.

Prior MWBE Subcontractor Goal – The remaining four contracts with the pre-2021 MWBE goal of 7.5% show an overall MWBE participation rate of 14.44%.

Current MWBE Subcontractor Goal – Contracts which have the current 15% participation goal show an overall MWBE participation rate of 22.20%.

Both goal categories show that the overall compliance rates of our in-progress projects are exceeding their stated contract goals.

M/W Labor Hours

A total of 24,149.53 labor hours have been worked by women and minorities on contracts that were still in-progress at the close of 2024.

Prior Minority & Women Labor Goal – Ongoing contracts with the prior labor goal of 17.8% show an overall M/W Labor rate of 12.39% at this point in their reporting.

New Minority & Women Labor Goal – Ongoing contracts with the current labor goal of 30% show an overall M/W Labor rate of 14.48% at this point in their reporting.

Labor numbers on in-progress contracts may be incomplete because labor reporting from the many subcontractors on these projects is often slow to be collected and submitted. However, at the close of the contract any delinquent reporting must be submitted before the final payment is issued.

Throughout the course of each project, this office continually monitors labor reporting, requests missing submittals, and notifies contractors as to where they stand in relation to the Labor goal.

ACDA Contracts – 2024 ACDA contracts show an overall MWBE participation rate of 53.88% and an M/W Labor rate of 79.25%. ACDA contracts are where we typically see the best compliance. ACDA projects are the rehabilitation of smaller properties, and there are many local MWBEs that can take on jobs of this size. These MWBEs tend to employ M/W labor at higher levels. ACDA projects are where we are most likely to achieve as much as 100% M/W labor.

Most-Awarded Contractors

The table below shows a breakdown of the contractors who hold the most contracts in the 2024 analysis. For the purposes of this table, the small ACDA contractors have been removed from consideration; we are looking only at larger-scale public works projects. Below are the contractors who were awarded (having submitted the lowest bid) three or more of the contracts included in the 2024 analysis.

Since this table combines both completed projects and on-going projects with new or prior goals, the utility of the data is somewhat limited and does not represent final numbers for any of the contractors. This data does offer a snapshot comparison of some of the City's most frequent bidders, and their current MWBE compliance rates in relation to one another. Please note that Stilsing Electric is a WBE; this is why their participation is at 100%.

It is worth noting that New Castle Paving, a frequent low-bidder on the City's many Streets contracts, has improved their MWBE participation. In 2022 they were at only 2.88% overall; in 2023 they were at 3.47%. 2024's 7.6% figure, while still below the goal, represents a consciousness of the requirement and steps taken to increase participation.

Compliance Process

The Chief Compliance Officer is involved with projects from the pre-bid stage to the final payment:

- Discussing MWBE requirements with the department which manages the project;
- Attending pre-bid and pre-construction conferences to review contract MWBE requirements and answer questions from contractors;
- Attending Contract & Supply meetings where bid advertisements, bid openings, and contract awards and changes are announced.
- Reviewing the bids, approving or rejecting MWBE and Labor plans submitted with the bids;
- Communicating with bidders whose MWBE or Labor Utilization plans are inadequate, advising them of the goals and options, and not approving the contract until the plans are acceptable;
- Monitoring the progress of compliance as the payment vouchers are submitted, maintaining logs detailing the reporting collected, and informing contractors they must improve when deficiencies are found;
- Conducting a waiver process when necessary;
- Recommending against re-hiring a delinquent contractor.

Other MWBE Program Functions

- The Chief Compliance Officer acts as a liaison with State and Federal agencies that provide funding and/or financing on City of Albany projects such as: EFC, DEC, DOH, DOT. This involves reviewing the MWBE/DBE/SDVOB requirements on each applicable contract and helping City departments and our contractors to document their compliance and submit all required paperwork as well as ongoing reporting. The Chief Compliance Officer participates in bi-weekly meetings with Water Department and EFC (Environmental Facilities Corp) personnel to review and track compliance issues regarding ongoing projects.
- The Chief Compliance Officer acts as a personal resource to City of Albany MWBEs and prospective MWBEs, holding frequent one-on-one meetings with Minority and Women Business Owners to discuss aspects of their business, such as how to apply for City or State MWBE Certification and how these programs work, or issues MWBEs face involving prime contractors, among many other topics. MWBEs are directed to outside resources they may utilize for training, financing, business planning advice, and free legal advice.
- Attending MWBE advocacy and outreach events at both the State and local level.
- Researching the MWBE and related programs of other municipalities. Responding to proposed changes to the City's MWBE Ordinance with input based on years of acquired knowledge and experience.

Outreach and Program Development

2024 has been a big year for community outreach in the MWBE Program

- The City of Albany MWBE Newsletter has been revitalized, given a new look, and its list of recipients greatly expanded to include many community stakeholders and City contacts who are in a position to spread the word about the MWBE program, special events for MWBEs, and contracting opportunities. The Newsletter goes out, at minimum, bimonthly – following each meeting of the Board of Contract and Supply.
- The Compliance Office began holding Open Office Hours every Thursday from 2:00 – 4:00. While City of Albany Certified MWBEs or potential applicants may reach the office by email or by phone and schedule an in-person appointment anytime, maintaining weekly Open Office Hours provides a reliable opportunity to connect for those who would like to drop-in.
- The Compliance Office kicked off a Quarterly MWBE Workshop Series, which has been well-attended and enthusiastically received. Attendees are current MWBE owners, Minority and Women entrepreneurs who are interested in becoming certified, as well as interested community members who are invested in the success of the MWBE Program. Attendees make connections, learn about the City of Albany MWBE Program, learn from scheduled speakers, provide feedback about their experiences, and get personal assistance from the Compliance Office. Attendees complete a questionnaire wherein they have the opportunity to ask for additional information or assistance, and the Chief Compliance Officer follows up regarding each request following the workshop.
- In 2024, the Chief Compliance Officer attended several functions at the State level:
 - NYS Division of MW Business Development Quarterly Partners Meetings
 - The NYS MWBE Forum
 - The NYS Association of Black, Puerto Rican, Hispanic & Asian Legislative Conference
 - NYS 2025 Budget Presentation by the Commissioner of NYS OGS
 - 2025 MWBE Advocacy Day at the NYS Legislature

The Compliance Office administers the list of City of Albany-certified MWBEs. This includes managing certifications, denials, and recertifications, updating the MWBE directory and publishing the revised version on a monthly basis.

The current list of City Certified MWBEs has 121 total firms, and is comprised of 46% Women-owned businesses, 36% Black-owned businesses, 10% Hispanic-owned businesses, and 8% Asian-owned businesses.

Denials

Businesses which are denied City of Albany Certification have 30 days to appeal the decision. There were no denials of certification in the year 2024.

The City of Albany Certified MWBE Directory

The Chief Compliance Officer maintains the City's directory of Certified MWBEs, which is organized by service-type. The directory is updated on a regular basis and is available to the public via the City website. Additional Notes

Additional Responsibilities of the Compliance Office

The Compliance Office tracks and reports on additional areas of compliance beyond the MWBE program. Other areas of responsibility for this office include monitoring and enforcing the City's Living Wage and Apprenticeship requirements.

NYS Empire State Development 2024 Disparity Study

In 2024, NYS ESD completed its most recent disparity study which is an extremely detailed analysis of MWBEs in the state of New York. The main purpose of the study is to determine the availability of MWBEs in different business sectors and in the various regions of the State, and to evaluate whether MWBEs are being utilized on NYS contracts to a degree that matches their availability to participate. This data is a valuable resource for the municipalities of New York State and should be used when evaluating local MWBE Program goals and performance. Attached to this report is Appendix D of the Disparity

Study, which contains the study's tables that relate to the Capital District. The second page, Table D-2, has to do with the availability of Minority and Women Owned Construction firms in our region.

The State has found that, in the Capital District, total availability of MWBEs to participate on Construction contracts is 26.06%. Of that 26.06%, 23.07% of the available construction firms are owned by Non-Minority Female Owners. 2.99% are owned by Minority Owners (all minority groups are included together in this figure, although the table also breaks down the data into separate minority groups.)

The other tables in Appendix D are also very useful, covering "All Procurement Categories," "Construction-Related Services," and "Non-Construction Related Services" in the Capital District.

It's fortuitous that there exists currently this up-to-date reliable data set. When considering changes to the City's program goal percentages, we should take this information into consideration.

I look forward to stewarding this thriving program through the continued growth and expansion that the upcoming year will bring!
