A Constituent's Guide to the Albany Common Council, Part 11: Minute by Minute

Each month, we'll go back to basics on all things Common Council.

Need to know how your councilmember voted? Look no further than the published meeting minutes. Meeting minutes, kept by the City Clerk, serve as the official record of the proceedings of each meeting of the Common Council.

New York State's [Open Meetings Law](#) provides the minimum guidelines and maximum timelines for releasing meeting minutes to the public. The minutes must both: consist of a record of all motions, matters voted on, and the vote counts taken by the body; and they must be released to the public, even if only as a draft, within two weeks from the meeting date. If the Council (or any other public body) finds it necessary to enter into Executive Session at any point during a meeting, minutes from that meeting must be made available within one week instead.

Even though Open Meetings Law only requires that the key information from meetings be entered into the official record, the Common Council strives to ensure that its minutes contain as much information as possible in an effort to govern openly and transparently. This includes information on the public hearings conducted, public comments given during the meeting, communications received from city officials, and miscellaneous business that does not neatly fit into business voted on by the Council. These can be found in their respective sections in the minutes.

Meeting minutes for a *Regular Meeting*, on the other hand, are included alongside the Agenda, Supporting Legislation, and Active Legislation to give constituents a one-

stop-shop for all of that meeting's materials. You can reach them by clicking into the agenda entry and scrolling through the outline until you reach "Minutes".
