## A Constituent’s Guide to the Albany Common Council, Part 12: Not Hard of Hearings

*Each month, we’ll go back to basics on all things Common Council.*

Communication is a two-way street and that is readily apparent when the Common Council holds a public hearing. As opposed to the Public Comment period, Public Hearings open the floor up for councilmembers and constituents to engage in a back and forth discussion on specific legislation. This helps councilmembers engage with members of the public while keeping the discussion on the merits of the legislation being discussed.

While the Common Council may call a public hearing for any legislation before it, public hearings are also required in a number of circumstances. For instance, the Unified Sustainable Development Ordinance (USDO), which outlines how the City of Albany zones its neighborhoods, requires that the Common Council hold a public hearing on any changes to the zoning map and text before passage. Grant programs may also require the Common Council to conduct a public hearing before accepting an application to ensure that the community’s voice is heard. Additionally, come October and November, the Council will hold public hearings to hear from constituents about their budget priorities.

It is imperative that public hearings are publicly noticed. The public needs to know when they will occur and how to participate. You can expect to find a copy of the printed legal notice or notices in the agenda for the meeting at which the hearing will be held, but if you subscribe to the newspaper of record, the Times Union, or frequent their legal notices page, you can also find them printed or posted there. Finally, the Common Council ensures that there is a posted notice on the bulletin board outside of the Council Chambers in City Hall as well as on the [City website](#).
