## A Constituent's Guide to the Albany Common Council, Part 13: Hop on Board!

*Each month, we'll go back to basics on all things Common Council.*

Have you ever wondered how you could be more engaged in Albany? Look no further—join a City of Albany board or commission! The City is made up of several boards that allow Albany residents to have an influence on the issues and projects most important to them.

Once the Common Council creates a commission or board, the Mayor or the Common Council—whichever is responsible for appointing members—searches for interested individuals to get involved. Members across all the boards and commissions must be City of Albany residents, possess a reputation of fairness and integrity, and reflect the diversity of city.

Each board has different powers and responsibilities. For instance, the Planning Board reviews site plans submitted by those wishing to develop land in the City, while the Sustainability Commission focuses on advancing sustainable practices and uniting action on climate change within Albany. The Common Council is currently looking for applicants to serve on the [Commission of Human Rights](#) and the [Task Force on the Municipal Flag](#). Members of the Commission on Human Rights seek to assure that the residents of our City are safeguarded against all forms of discrimination in violation of state and local law. Members of the Task Force on the Municipal Flag will be responsible for creating a contest where the public can submit proposals for a new City of Albany flag. The task force will review submissions, choose finalists, and create a forum for members of the public to vote and select the new flag! ## Committee Reports

### Human Resources and Human Rights Committee

The committee met on July 8 to discuss implementing family leave benefits for City employees (Ordinance 16.51.24) and establishing an ad hoc committee on Ethics and Workforce Culture (Resolution 64.61.24). ### Public Safety

The committee met on July 9 and July 17 to discuss transitioning the Community Police Review Board into the City structure (Local Law D of 2024). At the July 17 meeting, the local law passed out of committee with a favorable recommendation. The full text of the legislation can be found [here](#).

### General Services, Health and Environment
