IMPORTANT INFORMATION REGARDING SIDEWALK & BARRICADE PERMITS

- No lifts or scaffolding will be permitted within 10' of national grid wiring without the wiring being wrapped or the power diverted by national grid
Trees must be protected with barricades
Members of the Albany Police Department and Buildings and Regulatory Compliance will enforce the provisions of this permit
The fee for this permit application, which may be paid at our office by check or credit card, is \$75 or \$50 if associated with ongoing permitted work
The grantee must take all precautions to prevent accidents and must place barricades and lights on all openings or bridge openings where necessary
Barricades must comply with industrial code rule 23
Work must comply with the law and the plans submitted with this application

IMPORTANT INFORMATION REGARDING SIDEWALK & BARRICADE PERMITS (CONTINUED)

- AN ADA COMPLIANT, UNOBSTRUCTED PEDESTRIAN WALKWAY MUST BE MAINTAINED BY THE CONTRACTOR AT ALL TIMES THROUGH OR AROUND THE WORK ZONE OR OBJECT/CONTAINER/SERVICE VEHICLE THE APPLICANT IS SHOWING IN THIS PERMIT APPLICATION.
- LOOSE, GRANULAR MATERIAL SUCH AS CRUSHER RUN OR OTHER FILL MATERIALS SHALL NOT BE STORED IN THE ROADWAY OR SIDEWALK UNLESS SECURED INSIDE OF A CONTAINER OR OUTSIDE OF THE PUBLIC RIGHT OF WAY.
- CONSTRUCTION VEHICLES, CONSTRUCTION CONTAINERS, DUMPSTERS, AND MOVING CONTAINERS MUST HAVE REFLECTIVE TRAFFIC CONTROL DEVICES PLACED AROUND THEM WHEN THEY ARE WITHIN THE PUBLIC RIGHT OF WAY.
- CONSTRUCTION VEHICLES AND TRAILERS MUST NOT OBSTRUCT TRAFFIC AT ANY TIME.
- CONSTRUCTION CONTAINERS AND MOVING CONTAINERS SHALL REMAIN FOR NO LONGER THAN 14 DAYS PER GENERAL CITY ORDINANCE
- THIS PERMIT IS NOT A PARKING PERMIT. TO OBTAIN TEMPORARY PARKING ARRANGEMENT, CALL 518-434-5791 THREE BUSINESS DAYS PRIOR TO FIRST DATE PARKING IS NEEDED.
- CONSTRUCTION CONTAINERS, DUMPSTERS, AND MOVING CONTAINERS SHALL NOT BE PLACED ON PUBLIC STREETS IN HANDICAP PARKING AREAS, BLOCKING FIRE HYDRANTS, LOADING ZONES, OR OTHER AREAS WHERE THEY CAUSE AN OBSTRUCTION AND PUBLIC HAZARD
- BUILDING MATERIALS SUCH AS BLOCK OR WOOD SHALL NOT BE STORED IN THE ROADWAY OR SIDEWALK UNLESS ON A PALLET AND PLACED AGAINST THE BUILDING OR OUTSIDE OF THE PUBLIC RIGHT OF WAY
- IN THE EVENT THE WORK OUTLINED IN THIS PERMIT REQUIRE LANE CLOSURES, A MAINTENANCE AND PROTECTION OF TRAFFIC PLAN SHALL BE SUBMITTED WITH THE APPLICATION FOR REVIEW AND APPROVAL. ANY APPROVED LANE CLOSURES SHALL ONLY OCCUR BETWEEN THE HOURS OF 9AM-3PM UNLESS OTHERWISE APPROVED IN WRITING BY TRAFFIC ENGINEERING. WHEN FLAGMEN ARE REQUIRED AS PART OF THE MAINTENANCE AND PROTECTION OF TRAFFIC PLAN, THEY SHALL BE DEDICATED TO THAT TASK
- CONSTRUCTION CONTAINERS, DUMPSTERS, MOVING CONTAINERS AND LIFTS **MUST BE REMOVED DURING DECLARED SNOW EMERGENCIES.**
- PARKING RESTRICTIONS IN METER PARKING AREAS, THERE IS A FEE OF \$15 PER DAY PER METER PAYABLE TO THE ALBANY PARKING AUTHORITY ONCE APPROVED BY TRAFFIC ENGINEERING, NOT ALL REQUESTS WILL BE APPROVED. FOR APPROVAL, CALL 518-434-5791 SEVENTY-TWO HOURS PRIOR TO THE FIRST DATE PARKING IS NEEDED. PLEASE HAVE THE PARKING METER NUMBERS FOR THE SPACES NEEDED WHEN YOU CALL.
- LIFTS AND CRANES MUST HAVE REFLECTIVE STRIPES, CONSTRUCTION CONES OR CONSTRUCTION BARRELS AROUND THEM AT ALL TIMES WHEN WITHIN THE PUBLIC RIGHT OF WAY. A GROUND MAN MUST BE STATIONED AT THE LIFT ASSURING SAFETY UNDER THE OPERATING BASKET.
