A Constituent's Guide to the Albany Common Council, Part 5: How do committees work?

Each month, we'll go back to basics on all things Common Council.

Most legislation heads to committee after its introduction. The Common Council [Rules of Procedure](#) outline the roles of the Council's [nine standing committees](#), which consist of five councilmembers appointed biennially—that's once every two years—by the President Pro Tempore. The first councilmember listed on each committee roster is that committee's chair.

Committee chairs call meetings when legislation in the committee's possession needs considering or when matters related to the committee's jurisdiction need discussing. When it comes to considering legislation, committees are the site of the bulk of the Council's conversations on proposed laws. Department heads, City employees, elected officials and constituents often join in on these conversations, and their result is usually one of a few possibilities: A committee might decide to hold a piece of legislation for future consideration, to recommend certain changes to the legislation or to move legislation forward with a favorable recommendation. In these last two cases, it's back to the full council for a vote upon the legislation's amendment and passage, respectively.

While some committees are more active than others—the Finance, Assessment and Taxation Committee, for example, meets frequently during budget season in October and November—all committees must hold at least two meetings each year. Committee Reports

Public Safety Committee

The committee met on October 3 to discuss Resolution 97.101.23R, Resolution 98.101.23R and Ordinance 5.21.23, each of which can be found [here](#). Resolution 97.101.23R moved forward with a favorable recommendation; Resolution 98.101.23R was held. Ordinance 5.21.23 moved forward with a favorable recommendation pending amendments.

The committee met on October 16 to discuss Resolution 98.101.23R and Ordinance 5.21.23. Both the resolution and the ordinance moved forward with favorable recommendations.¹

Finance, Assessment and Taxation Committee
