A Constituent's Guide to the Albany Common Council, Part 6: What are all those meeting documents?

Each month, we'll go back to basics on all things Common Council.

Council staffers prepare a set of documents for councilmembers and constituents ahead of every Regular Meeting. Each of these documents is related to the legislation before the Council, and each serves a different organizational purpose. You can follow along with the below examples by heading to the [December 4 Regular Meeting page](#) in the Council's Agenda Center.

The [Agenda](#) has two main functions: It lays out the order of operations for each meeting, and it catalogues the titles and locations of each piece of legislation being considered by the Council. This second function makes it a useful tool for tracking legislation as it's introduced—see the Local Laws, Ordinances, or Resolutions Introduced sections—and as it heads through committee—see the Local Laws, Ordinances, or Resolutions Held sections.

Staff compile all legislation set to be introduced to the Council in a packet called the [Supporting Legislation](#). Here, you'll find not only the titles of new pieces of legislation but also their full texts.

If you're looking instead for the previously held legislation that the Council is set to vote upon, you'll find it in the [Active Legislation](#). Like the Supporting Legislation, this packet contains the titles and full texts of relevant local laws, ordinances, and resolutions.

The [Active Calendar](#) lists the title of each piece of legislation up for a vote at the Regular Meeting. This document sometimes includes notes on steps needed for the legislation's passage—discussions at a scheduled meeting or amendments prior to a final vote, for example.

Staff publish the Agenda, Supporting Legislation, Active Legislation, and Active Calendar prior to each Regular Meeting's associated Caucus/Work Session. You can find these documents and more in the Council's [Agenda Center](#).
